

## Annual St George's Research Ethics Committee (SGREC) Report 2019 - 2020

This statement has been produced by the Research Ethics and Integrity Officer, St George's University of London, in accordance with the SGREC Modus Operandi. It has been approved by St George's Council and will be made publicly available on the University website.

St George's is strongly committed to carry out the research to the highest ethical standards. This includes not only the researchers, but staff in policy and management roles, along with the chair and members of the research ethics committee. We believe that the quality of the research ethics review is fundamental to our research integrity. We have the policies, processes, governance and culture to promote and ensure research integrity across St George's.

This annual statement covers the period 1<sup>st</sup> August 2019 to 31<sup>st</sup> July 2020.

# 1. Summary of actions and activities that have been undertaken to support the work of

#### the Committee

- i) Research ethics webpage: In May 2020, we created a new research ethics webpage (https://www.sgul.ac.uk/research/research-ethics) which provides information for researchers on the ethics review process and St George`s Research Ethics Committee.
- ii) The Research Ethics and Integrity Officer (REIO) provided expert guidance on research ethics.
  - 13.03.2020 Team meeting of Molecular & Clinical Sciences Research Institute (15 participants)
  - 01.06.2020 Seminar for staff Molecular and Clinical Sciences Research Institute (20 participants)
  - 21.07.2020 Seminar for staff Institute of Medical and Biomedical Education (6 participants)
- iii) The Research Ethics and Integrity Officer (REIO) provided drop-in sessions for students.
- iv) St George's has a subscription to the UKRIO, which is an independent charity which provides support and webinars in relation to matters of research ethics, research integrity and research misconduct. The UKRIO provided training to the SGREC members on Research Ethics in March 2020.
- v) An audit of the St George`s University of London Research Ethics Committee (SGREC) was conducted in May 2020. The review was based on the requirements set out in the 'Research Ethics Support and Review in Research Organisations' guidance of UK Research Integrity Office and Association of Research Managers and Administrators (2020). The audit established that the SGREC is 95% compliant with these requirements.

### vi) The identified fields for improvement in the Audit:

- Increase the diversity of the SGREC with people from other institutes such as Population Health, Joint Faculty, St George's NHS Trust medical staff, industry and the local community
- Develop a policy for the SGREC recruitment and training

- Develop and update institutional research ethics and integrity policies (such as a Code of Conduct for researchers, Research misconduct procedures)
- Update the Constitution and Terms of Reference for the ethics committee
- RECs should normally expect reports from researchers detailing any serious and unanticipated adverse events arising during the research
- Provide supportive ethics reviews

### vii) Actions for improvement:

- SOP for recruitment and training policy for SGREC was approved in May 2020
- The Code of Conduct for researchers has been drafted and is awaiting approval
- The research misconduct procedures, the feedback from UK Integrity Office (UKRIO) received, updates are in progress
- The SGREC SOP has been updated with the actions for serious and unanticipated/significant adverse events arising during the research
- The Terms of Reference and the Modus Operandi was updated in May 2020
- SOP for monitoring of high risk SGREC cases was approved in July 2020
- The SGREC forms and templates were updated in May 2020 to provide further support for researchers
